recent settlements

At the Dental Law Partnership we have been successful in settling negligence claims covering a wide variety of dental treatment from routine dentistry including fillings or gum disease treatment, to more complex treatment such as root canal work, crowns, bridges and cosmetic treatment.

Hughes v T

Out of Court Settlement 23/01/2006

The Claimant, a 40-year-old woman, received £17,500 as a result of the defendant's failure to diagnose and treat decay and the provision of poor root treatment and crownwork which has resulted in the Claimant losing 6 teeth.

Berzin v K & T

Out of Court Settlement 03/02/2006

The Claimant, a 63-year-old woman, received £26,685 as a result of her dentist's failures during the placements of 2 implants in 2002. The Claimant required extensive oral surgery and restorative treatment to correct the problems.
